OFFICE MEMORANDUM

SUBJECT: Authorization/supply of uniforms/scales to certain un-common and isolated categories of Gp-'C' & 'D' Employees – regarding.

The undersigned is directed to forward herewith a proposal for 'authorization/supply of uniforms/scales to certain un-common and isolated categories of Gp-'C' & 'D' Employees' of the five Institutes under MT Dte, namely, Officers' Training Academy (OTA), Chennai, Army War College (AWC), Mhow, Infantry School, Mhow, Junior Leaders Academy (JLA), Bareilly and Military School (MC), Chail to meet the functional necessity of respective institutions.

2. The Supply of uniforms to Gp 'C' & 'D' employees is proposed to be governed by the provisions of GoI Min of Def OM No. 12(1)/87/D(Civ-II) dated 28.09.1987 read with DOP&T OM NO. 14/8/86-JCA (Vol-III) dated 23.07.1987. The proposal was forwarded to the Ministry of Defence (Finance) for their concurrence. The Defence (Finance) has, however, advised that this case be taken up with 6th CPC as the Commission has requisite the expertise to take a conscious decision in such a matter.


3. The quality, scale and rate of uniforms to be issued are proposed to be at par with other Gp-'D' employees, in vogue. The total Financial Implication will be Rs 5,20,578/- per year. The Institute-wise detail is:
