Subject:- Payment of 10% arrears of pay to Territorial Army (TA) and Re-employed Defence Personnel pending issuance of notification accepting 7<sup>th</sup> Central Pay Commission Award.

Sir,

The following amendments are made to this Ministry's letter No.1(11)/2016/D(Pay/Services) dated 10 October 2016.

(a) After Para 2, add new Para 3 and 4 as under and re-number existing paras 3 and 4 as 5 and 6:-

“3. The above provisions will also be applicable to Territorial Army Officers (upto the rank of Brigadier), JCOs and Other Ranks (other than MNS(TA) who are on the embodied strength of TA as on 01 Jan 2016 and continue to be embodied as on the date of promulgation of this letter under one or more of TA Act Rules 21-A (Permanent Staff), 33 (Military Service), 19(Recruit Training), 20 (Annual Training), 20A(Post Commission Training) and 21(Voluntary Training), without any break in embodied status in between”.


“4. The above provisions will also be applicable to re-employed officers who were re-employed on or before 01 Jan 2016 and continue to be re-employed as on the date of promulgation of this letter. However, amount of adhoc arrears will be restricted to 10% of pay, as being drawn on re-employment as on 01 Jan 2016.”

(b) Substitute renumbered Para 5 of letter dated 10 Oct 2016 with the following:-

“Expenditure on account of payment of arrears on adhoc basis is debitable to the relevant Pay and Allowance heads of Defence Services as the case may be”.

2. This issues with the concurrence of Finance Division of this Ministry vide their Dy. No.Mod(Fin)/443-PA dated 25.11.2016.
