A total of 340 applications as Expression of Interest (EoI) have been received under TDF Scheme for the awarded projects so far. Total time taken for processing the application till award of the project is 06 months on an average for a normal case.

It is a continuous process where payments are linked with the milestones achieved for the specific projects. It takes approximately 45 days for disbursement into the account of the company from the date of submission of bill alongwith relevant supporting documents received from the company.

REPRESENTATION OF EX-SERVICEMEN IN GOVERNMENT DEPARTMENTS

The existing quota of reservations available for Ex-Servicemen (ESM) is as follows:

- ➤ Public Sector Banks (PSBs) and Central Public Sector Undertakings (CPSUs):
 - 14.5% in all Direct Recruitment Group 'C' Posts.
 - 24.5% in all Direct Recruitment Group 'D' Posts.

(Including 4.5% for Disabled ESM and dependents of Service personnel killed in action)

- ➤ Central Civil Services & Posts (CCS&P) of Central Government Ministries/ Departments and Central Armed Police Forces (CAPFs):
 - 10% in all Direct recruitment posts upto the level of Assistant Commandant in Central Armed Police Forces (CAPFs).
 - 10% in all Direct Recruitment Group 'C' Posts.
 - 20% in all Direct Recruitment Group 'D' Posts.
- > 100% in Defence Security Corps

Reservation for ESM is against direct recruitment vacancies only, number of which is worked out by the appointing authority, as and when recruitment process is initiated. As per available data, year-wise recruitment of ESMs during last five years, as on 31.12.2021, is as follows:

No independent assessment has been done. However, for the purpose of improving number of recruitments of ESMs, advisories have been issued, from time to time, to all concerned Department/CPSUs/Banks/State Governments for conducting special drive to fill up backlog of vacancies reserved for ESM and for adoption of relaxed standards of qualifications for their recruitment. Liaison Officers have also been appointed in various Departments/PSUs/Banks to ensure implementation of reservation policy for ESM.

Total number of personnel enrolled in the DGR for Resettlement Training/Skill Courses during the last 05 years (2017-18 to 2021-22) is as under:

Trainees after completion of training/course are not reporting back when they secure a placement, as such these numbers are not being separately maintained. During last five years only one widow of officer was enrolled for Resettlement Training Course and nobody got enrolled from JCOs/OR.

FINANCIAL ASSISTANCE TO THE DEPENDENTS OF MARTYRED SOLDIERS

The Government has made various provision to provide concession in education, health and other facilities to the children of martyred soldiers.

- ➤ Children Education Grant: Following educational concession is being given to officers/Personnel Below Officer Rank missing/disabled/killed in action:
 - **Tuition Fees**: Full reimbursement of tuition fee (Capitation fee and caution money not included) levied by the educational institutions concerned (including charges levied for the school bus maintained by the school or actual fares paid for railway pass for students or bus fare certified by the Head of Institutes).
 - **Hostel Charges**: Full reimbursement of Hostel charges for those studying in boarding schools and colleges.
 - **Cost of books/stationary:** Rs. 2000/- (Rupees two thousand only) per annum or the amount claimed by the student, whichever is less.
 - Cost of Uniform where this is compulsory: Rs. 2000/- (Rupees two thousand only) or the amount claimed by the student, whichever is less.
 - **Clothing:** Rs. 700/- (Rupees seven hundred only) per annum per student or the amount claimed by the student, whichever is less.
 - **Free Health Scheme:** ECHS (Ex- Servicemen Contributory Health Scheme) provides cashless health care to war-widows/war disabled defence personnel and their NoKs. War Widows are not required to pay the membership fee.

> Other facilities:

There are other resettlement schemes also run by the Directorate General of Resettlement (DGR) like allotment of petrol pumps etc. to ensure proper resettlement of war widows/ dependents.

The financial assistance is provided to family/ dependents of martyred soldiers. Details are as follows:

INDIAN NAVY

Pensionary benefits (LFP/SFP/OFP, Ex-Gratia, DCRG/Gratuity) as per entitlement are paid to NOKs of the Naval Personnel. Financial assistance in terms of benefits like ex-gratia is provided under various categories to widows & dependents of deceased soldiers as per pension regulation promulgated by the Government. Family pension and gratuity to families and dependents is based on the last pay drawn and last rank held by the deceased soldiers at the time of his death whilst Ex-gratia amount is given to the NoK of a soldier killed in action or in course of duty irrespective of rank and qualifying service, based on circumstances of death. Ex-Gratia compensation are given in the range of Rs.25-45 lakhs.

INDIAN AIR FORCE

An institutional mechanism by way of Standard Operating Procedure (SOP) for timely dispensing of pension and other Non-Effective(NE) benefit to NoK/dependents has been put in place in IAF. However, the following Pensionary benefits are being provided to the Next of Kin (NoK) of the Air Warriors killed in action as per the Govt Policy.:-

• **Liberalized Family Pension (LFP):**Liberalized Family Pension (LPF) is being granted to Next of Kin of the Air Warriors killed in Action. It is

granted in case of death of an Armed Forces Personnel due to acts of Violence/attack by terrorist, anti-social elements, enemy action in international war, action during deployment with a peace keeping mission abroad, border skirmishes etc. It is granted @ 100% of reckonable emolument + admissible Dearness Relief applicable from time to time. It continues even after re-marriage of the widow.

- **Death cum Retirement Gratuity (DCRG)**: It is payable to the widow/ NOK/ nominated family member of the deceased officer/Airmen/NCs(E) who die in harness as per the length of qualifying service.
- **Ex-Gratia Payment:** Ex-gratia Lump Sum Compensation given as per the following details:-

- **Modified Scooter Grant**: Rs one lakh provided to those ESM, who are disabled after service with a disability of 50% or more and who are not covered under the scheme of AG's Branch of IHQ (Army, Navy & Air Force).
- **Subsidy on Home Loan**: KSB Reimburses 50% of interest by way of subsidy on home loan from Bank/public sector institutions for construction of house to war bereaved, war disabled and attributable peace time casualties. Rs 1,00,000/- (Max)
- **Prime Minister's Scholarship Scheme**: Total 5500 scholarship are provided to eligible wards based on merit for the entire duration of the courses. The rates of Scholarship are as follows: -
 - (a) Rs. 2500/- per month for boys.

SPACE DEFENCE MISSION

Mission DefSpace was launched by Hon'ble Prime Minister during DefExpo in October, 2022 with 75 Defence Space Challenges relevant to the end users. These challenges have been categorised into existing DDP initiatives of iDEX, Make-I and Make-2. Private Industries, including Start-ups, MSMEs and Individual Innovators, are eligible to apply. The challenges, classified into five buckets viz. Launch System, Satellite System, Communication & Payload System, Ground System and Software System, provide a holistic 360° overview of space.

The Government has taken several policy initiatives in the past few years and brought in reforms to encourage indigenous design, development and manufacture of defence equipment, there by promoting self-reliance in defence manufacturing & technology in the country. These initiatives, inter-alia, include according priority to procurement of capital items from domestic sources under Defence Acquisition Procedure (DAP)-2020; Announcement of 18 major defence platforms for industry led design & development in March 2022; Notification of four 'Positive Indigenization Lists' of total 411 items of Services and three 'Positive Indigenization Lists' of total 3738 items of Defence Public Sector Undertakings (DPSUs), for which there would be an embargo on the import beyond the timelines indicated against them; Simplification of Industrial licensing process with longer validity period; Liberalization of Foreign Direct Investment (FDI) policy allowing 74% FDI under automatic route; Simplification of Make Procedure; Launch of Innovations for Defence Excellence (iDEX) scheme involving start-ups & Micro, Small Medium Enterprises (MSMEs); Implementation Procurement (Preference to Make in India) Order, 2017; Launch of an indigenization portal namely SRIJAN to facilitate indigenization by Indian Industry including MSMEs; Reforms in Offset policy with thrust on attracting investment and Transfer of Technology for Defence manufacturing by assigning higher multipliers; Establishment of two Defence Industrial Corridors, one each in Uttar Pradesh and Tamil Nadu; Opening up of Defence Research & Development (R&D) for industry, startups and academia with 25 percent of defence R&D budget; and Progressive increase in allocation of Defence Budget of military modernisation for procurement from domestic sources, etc.

No post is vacant for women in Indian Army. Sanctioned posts in Indian Navy and Indian Air Force are gender neutral.

Government has taken number of steps to increase women participation in the Defencesector. These include:

Army

Combat employment philosophy of women in the Armed Forces is a continuously evolving process and regularly reviewed by the Indian Army. At present, the women are being commissioned in Indian Army in ten Streams viz. Corps of Engineers, Corps of Signals, Army Air Defence, Army Service Corps, Army Ordnance Corps, Corp of Electronics and Mechanical Engineers, Army Aviation Corps, Intelligence Corps, Judge Advocate General Branch and Army Education Corps in addition to the

Armed Forces Medical Services as Doctors and Military Nurses which is a women only entry. New Avenues such as grant of permanent commission to SSC women officers, induction of women cadets in NDA, recruitment of Women as Provost JCOs/OR.

Navy

The induction of women as officers in the Indian Navy commenced in the year 1991. Since then the Indian Navy has gradually opened all branches to women officers including induction through NDA. Further, for the first time women are also being recruited for sailors' entries under the Agnipath Scheme *w.e.f.* 2022 and 20% vacancies are reserved for women.

Air Force

Officers recruitment in the IAF is gender neutral. Women officers are inducted in all the branches and streams of IAF. Opportunities for a career in IAF service are widely publicized through print/ electronic media and special publicity drives. An opening has also been provided through NCC Special Entry for flying SSC (Women) from July 2017 onwards. The experimental scheme to induct women officers in all combat roles, initiated by the IAF in 2015 has now been regularised into a permanent scheme. Such gender neutral approach is facilitating the employment of women officers of IAF in all combat roles without any restrictions.

No study has been undertaken regarding the low participation of women as there has been a steady growth in the induction of women in the armed forces.
